Protect Your Research!

The Allen County Public Library in Fort Wayne, Indiana, is well-known for its genealogy collection. Its recent e-newsletter contained some good advice:

Our history is in our hands. That's the way it should be—the way we want it to be. Now let's take responsibility for it.

That was the conclusion to an article about online databases. It reminded us that the Master Genealogist, once considered the “cadillac of genealogical data management programs,” went out of business several years ago. More recently, Ancestry was going to discontinue Family Tree Maker until the outcry forced them to sell it rather than kill it and, very recently, RootsWeb had a hardware failure and was not able to retrieve all of its data.

Please let this be a reminder to back up your digitalized records now if you do not have a service doing so automatically. If you are also concerned about paper records, documents, and photographs, contact the Genealogy Society about making paper and/or digital copies for you. It is always good to have an off-site copy of important papers, including all of the records you spent hours researching!



The Portland Collection

In February 2016, Betty Earlene Kelly donated a collection of records to the Walton County Heritage Association. The collection includes photographs, birth records, obituaries, and church records from Portland. The names included in the collection are too numerous to list here, so I have selected one family to follow through the records and online sources to illustrate the collection.



As noted on the back of the photograph, on May 21, 1922, Maggie Jane Fountain (left) married Edward Harley Hamilton. Harley was the son of W. J. and Dililah Hamilton, both born in Alabama. In the 1920 census, he was 19 and living with his parents on Basin Road in Portland, working as a laborer in "Public Work." Their neighbors included the Reddick, Taunton, Jernigan, Kelley, and Shaw families.

We first find Maggie and Harley Hamilton together on the 1930 Federal Census. It appears their first son Ottis was born around 1921 and four other children soon followed. However, as is often the case with census records, some of children's names and ages are incorrect.

Thanks to the Portland Collection, we know Ottis was born March 3, 1923, although he later used March 4 as his birthdate. The 1930 Census had his age wrong by two years.

The spelling and penmanship on the birth records are poor for the most part, so it is necessary to look at other records to verify names. In this case, it took the Florida Death Index to confirm that this was the birth certificate for Ottis rather than his brother Olin. Then the 1940 Federal Census made more sense, showing the boys' ages as 16 and 14, respectively. It listed Ottis as a "New Worker" with 5th grade as the highest grade completed. Since 1940 was the last released Census, other sources must provide more information.

Ottis K. Hamilton enlisted in the U.S. Army on March 9, 1943, at Camp Blanding, Florida. The U.S. World War II Army Enlistment Records, which were accessed on Ancestry.com, list him as single with the civil occupation of fisherman and oysterman. Fold3.com, a paid site owned by Ancestry, had him married and working as a farm hand at a dairy. It was wrong on both counts.



Artificial fishing reefs also came under heavy fire from the fishermen. Shrimp fisherman Ottis K. Hamilton told the legislators that the reef were hazardous for several reasons. "They drop those cars and things on shrimp beds," he complained. "And it becomes a menace to navigation, too." Hamilton explained that many of the things dropped to form the reef do not stay put but are washed along the bottom. Hamilton said he had no objection of closing the bayous for shrimp fishing.

The Florida Marriage Index shows that Ottis married Ruby Lee Grace in 1948. She was born on April 24, 1924, to Carl and Jane Grace of Niceville. Ruby and Ottis had a son, Jimmy Ottis Hamilton, who was born on August 24, 1949.

Ottis Hamilton was quoted in an article (*left*) in the *Playground Daily News*, Fort Walton Beach, "Fishermen Oppose Choctaw Net Law," on January 16, 1969, so we know that he was, in fact, a shrimp fisherman.

Little else is publicly known of Ottis Hamilton's life or the lives of his parents, Maggie and Harley Hamilton. That is why writing down family stories and donating them to the Genealogy Society is so important.

Ottis K. Hamilton passed before his parents. He died on March 24, 1974, and his wife Ruby died in 1985. Ottis and Ruby are buried in the Early Cemetery in Niceville along with their son, Jimmie Ottis Hamilton, who died on July 26, 2010.

I had to rely on gravestones to learn the birth, marriage, and death dates of Maggie Jane Fountain and Edward Harley Hamilton. Their obituaries provide some more information, mostly genealogical.


Mrs. Hamilton was a native and lifelong resident of Walton County.

Survivors include her husband, Edward Hamilton of Freeport; three daughters, Ophella Bianci of St. Petersburg, Bernice Griffin of Vero Beach and Kitturah Amison of Apalachicola; a son, Olin Hamilton of New Orleans; a sister, Mae Padgett of Pleasant Grove community; four brothers, J.E. Fountain of Mobile, Ala., Rayburn Fountain of DeFuniak Springs, Carl Fountain of Niceville, and Lavin Fountain of Rockville, Md.; 18 grandchildren; and 12 great-grandchildren.

Funeral services will be 2 p.m. Monday in the Comander Funeral Home chapel with Jack Parks officiating.

Burial will be at the Hatcher Cemetery.

DEFUNIAK SPRINGS — Mr. Edward Harley Hamilton, 87, of Portland, died late Saturday evening in a Niceville hospital.

Mr. Hamilton was a native and lifelong resident of Walton County and was a retired carpenter.

Survivors include three daughters, Ophella Bianche, of St. Petersburg, Bernice Griffin, of Vero Beach, and Kitturah Amison, of Apalachicola; a son, Olin Hamilton, of Freeport, and 18 grandchildren and numerous great-grandchildren.

Funeral services will be at 2 p.m. today from the Comander Funeral Home chapel with the Rev. Terry Van Gilder officiating.

Burial will follow in the Hatcher Cemetery.

Active pallbearers will be: Don Miley, Lorice James, Kenneth Taunton, Talmus Brown, Ebin King, and Damon Brown.

Honorary pallbearers will be: Clinton Wright, Irvin Godwin, Burress Godwin, David Kelley, and Conley Martin.

Comander Funeral Home is in charge of arrangements.

In addition to some photographs, birth records, and copies of obituary notices, the Portland Collection also has the Church Roll Record Book of the Pilgrim's Rest Baptist Church of Portland. The book lists members of the church and some notations, such as when someone was baptized. For example, it shows that Maggie Hamilton and her sister, Lizzie Mae Fountain, were received in the church in July 1924. J.D. Hattaway received a salary of \$60 that year as its Pastor, and it had 58 members. According to court documents, the church, which was also called Portland Baptist Church, ceased to exist around 1940.

Many of the records in the Portland Collection are very fragile, but I will be pleased to check copies of them for you. Free Online Genealogy Lessons

FamilySearch's Learning Center — FamilySearch offers hundreds of free courses, using videos, slides, and voice narration. Most have PDF handouts that provide additional information and links to web sources. If you are new to genealogy, they offer 21 five-minute genealogy lessons. Intermediate and advanced courses are also available, covering dozens of topics in 14 languages.

The Ancestry Learning Center has several dozen free research guides but most appear to promote use of the Ancestry.com website.

The Genealogy Center of the Allen County (Indiana) Public Library now offers two how-to videos and hopes to add more soon. The current videos are "Gathering Home Sources" and "The Research Process."
