

The Ghent and McDavid Families Of Walton County Revisited.

I recently received an Email from Ralph Ghent, of Mt. Airy, Maryland, thanking me for the information provided in the Walton Relations & History newsletters regarding the Cawthons and John and Mary Ghent. The newsletter of February 2018 contained an article titled “Ghentsville,” about the mail robber, John Ghent. He had been arrested and charged with theft of U. S. mail. The U. S. Marshall held him under guard on the third-floor of a hotel in Pensacola, because he did not trust the local jail to be secure enough to hold him. When the guards momentarily took their eyes off Ghent, he plunged through a window and plummeted three stories to the ground. Although surviving the fall initially, the severity of his injuries caused his death a few hours later.

It is gratifying to learn that the newsletter is being read by people living outside of Walton County, who, just by chance, are related to characters appearing in our newsletter articles. Ralph is a descendant of Fielding Ghent, a brother of John. This is not to suggest that Fielding played a role in his brother’s criminality, because there is no known evidence of it. The focus of this article is not on that, but rather on the relationship of the Ghent and McDavid families, of which I previously had no knowledge.

The connection between the two families seems to have begun with the marriage of Daniel Ghent (1777-1853) and Mary McDavid (1779-1825) in South Carolina, possibly in the Greenville area in the late 1700s. The families lived in the same area of the state and sometimes appeared in land records together. James McDavid, John McDavid and Fielding Gent are listed as witnesses on the “Will of Strother D. Shumate,” of Greenville District, South Carolina, dated August 3, 1834.

Daniel and Mary were the parents of Fielding (1806-1882), Nimrod (1809-1860), John (1810-1858) and Sarah Monima (1814-1881). John Allen McDavid was born in 1774 in Greenville South Carolina and died in 1838 in what was then Walton County, Florida. He is buried in Oak Grove Cemetery, in Baker, Okaloosa County, Florida. John Allen and Mary McDavid may

have been siblings, making John the uncle of Fielding and they may be the witnesses of those names listed on the Strother Shumate will of 1834.

John Allen McDavid married Nancy Acker. Their children were:

Richmond Terrell (1805-1871), m. Sarah McCaskill.

Mary A., m. Jeremiah Sevell (post master of Almirante P. O. as of 5 May 1828)

David (nothing else known of him)

Melinda, m. Jesse Mims

Joel Acker (1799-1854), m. Margaret Earle.

Lucinda, m. Abner or Joab Gaines.

John Allen Jr., m. Samantha Horn (Eli Horn postmaster of Almirante as of November 25, 1846. Possibly the father of Samantha).

A former name of today's Lake Jackson, straddling the state line between Paxton, Florida and Florala, Alabama, was McDavid's Pond. John Lee Williams called it that in his 1827 book, "A View of West Florida." Richmond T. McDavid appeared on the Walton County census of 1830 as a resident of the eastern part of the county. This suggests that Richmond T. was the namesake of McDavid's Pond as identified by John Lee Williams in his book. It is very likely that Richmond and John Ghent were first cousins, which may explain why Ghent moved from Santa Rosa County to that part of Walton County shortly before Florida statehood in 1845.

Although the lake later acquired the name McDade's Pond or lake, no documentation has been found explaining such a change in the name. It was suggested that McDavid later changed his name to McDade, but as Find a Grave memorial # 12328241 for Richmond T. McDavid's burial at Coon Hill Cemetery in Santa Rosa County, Florida, shows, he took the name McDavid to his grave, having never changed it to McDade. What seems more likely is that the McDade name came about due to the erroneous spelling of McDavid.

Ralph Ghent's email is shown on the next page, followed by a copy of the Shumate will and photos of a knife made by Fielding Ghent that is now owned by Ralph, who is Fielding's third great grandson.

Hi Sir,

I am Ralph Ghent, COL(Ret), US Army, and a direct descendant of Fielding Ghent (brother of John Ghent, who married Mary G. Cawthon and settled near Lake Jackson).

My line is:

My father = Frederick L. Ghent

My GF = Ralph Taylor Ghent

My GGF = Robert Taylor Ghent

My GGGF = Fielding Ghent, who had brothers John and Nimrod.

My GGGGF = Daniel Thomas Ghent

I have discovered your wonderful research and history in several Walton County Heritage articles re: the Cawthon's and John+Mary Ghent. Much of your great information jives with handed-down stories in my family regarding the irascible John Ghent, his theft as Postmaster in Ghentsville (Paxton), his demise leaping from a jail window and his 2nd burial upright (or seated) with pistols in hand (thanks to his loyal servant, Chap, who retrieved him from his first burial in/nearby Milton (where I believe Nimrod was residing at that time).

I must confess that I did not know that John Ghent was a State legislator (Florida), so your writings on that were very interesting.

The family stories did tell of Mary G. Cawthon and children leaving after John's mail-theft charges and death, and resettling in Texas. The explanation for the Texas move may be understood when we see that there was a half-brother of John Ghent who went west to Milam, Texas and settled his family there. It may be that Mary G. Cawthon joined that other Ghent to get a change of scenery, so to speak. That step-brother was Henry Clay Ghent (1831-1912). Henry Clay was a son of Daniel Ghent's 2nd wife (Nancy Wilson, 1796-1872), and he was a surgeon in the Confederate Army who later became a prominent physician in Bell County Texas.

I do have one question-mark in my lineage that perhaps you may be of help, sir. Of course, John Ghent's father was Daniel Thomas Ghent and Daniel's first wife (and the mother of John, Fielding and Nimrod) was a Mary McDavid (McDade?), as best as I may discern. But there is scant info on her. I do not know if it is Mary McDavid or Mary McDade ... and if she was possibly a descendant of another Florida family. If there's any chance you may have further info on her, then I would greatly appreciate it.

In closing, my wife and I have a small reunion planned in October in Destin, FL with a few of my retired military classmates from West Point (Class of 1975). As part of our trip to that area, we aim to take a few days and visit Florida, Lake Jackson area, Paxton, Milton, Brewton, and maybe run up to Dothan to trace some of John and Fielding's paths. I am most interested in seeing if there is a mound or gravesite with John Ghent buried upright and to see where John lived and the site of "Ghentsville." If by any chance you may be free in October, we would be most grateful to meet you and chat about John Ghent. I could show you a beautiful pocket knife that was handmade by Fielding Ghent and it is beautifully inscribed on the case with, "Fielding Ghent, Florida, 1864."

STROTHER D. SHUMATE

SOUTH CAROLINA GREENVILLE DISTRICT

I Strother D. Shumate being sound in mind and memory and bearing in mind the uncertainty of human life do make this my last will and testament first I bequeath my soul to God who gave it secondly I bequeath (after my funeral expenses and debts are paid) all my personal and real estate to my wife for her to enjoy during her lifetime or widowhood. If she should marry then I wish her to have a child's part At her decease or the expiration of her widowhood, I bequeath Penelope my youngest daughter two hundred dollars the balance to be equally divided between my nine Children.

I do appoint my oldest son Lewis H. Shumate and my wife Anna my Executors.

Given from under my hand and seal this 3d August 1834.

DeFuniak Springs Seeks National Historic Landmark Designation

LEAD: DeFuniak Springs Seeks National Historic Landmark Designation

Status as a National Historic Landmark is the highest, most exclusive, official recognition that the United States government bestows on its historic resources. Such a designation can greatly aid the economic development of an area. The City of DeFuniak Springs and Forward DeFuniak, Inc. are assembling a nomination packet for submission to the National Park Service seeking designation of the Chautauqua Campus/Area as a National Historic Landmark. The following progress has been made in this multi-year process.

1. A Core Working Group of 7 members nominated by the city, Forward DeFuniak and the community was formed. The City Manager, the Mayor, and the President of Forward DeFuniak are ex officio members of the group. Two meetings to determine duties and task assignments have been followed by telephone and e-mail contacts to track both accomplishments and needs. An additional group of community volunteers is being identified to assist in the process.

2. The Core group is identifying and collecting published histories of the Chautauqua movement in the US, the town's founding, and the local Chautauqua movement (1885-1930). With scarce resources found, it is attempting to identify the history of any Chautauqua activities locally from 1930 to the present. A national impact, rather than simply local, regional and/or state level impact, must be documented for success.

3. Xeroxed documents, books, and a four-page list of references to be used in the nomination, stand approximately two feet tall. Since all structures and sites in the defined area must be studied, the nomination document is expected to be several hundred pages long. It will be reviewed by historians across the United States before final review by the Secretary of the Interior.

Watch for follow-up articles on the progress of this important project. Core Group meetings are announced on the city web site and are open to the public. A slide presentation is available to groups or organizations outlining advantages and disadvantages, etc. of seeking this designation. Call 850-830-7663. You can also volunteer!
